

# LARSEN FIGHTS FOR OVERSIGHT AND ACCOUNTABILITY FOR ICE



President Trump's immigration enforcement agenda has brutalized families and children here in Northwest Washington and across our country.

**I am demanding that ICE follow the same rules as every other law enforcement agency.**

I will not vote for any **full-year** funding for the Department of Homeland Security and ICE that fails to create oversight and accountability. I am fighting for reforms to DHS to:

- Ensure **ICE and CBP immediately leave Minneapolis** and stop terrorizing American cities and communities;
- **End arrests without judicial warrants** and, outside of exigent circumstances, arrests at sensitive locations such as churches, shelters, schools, and courthouses;
- Ensure **full, independent, and transparent investigations** into all DHS-related shootings, including federal cooperation with state and local investigations, and ensure that federal agents are properly trained, appropriately supervised, and held fully accountable for their actions;
- **End the detention and deportation of U.S. citizens;**
- **End the anonymity of federal agents** by requiring them to remove their masks and provide identification;
- Provide **robust minimum standards of care at detention facilities** – including access to medical care, clean water, edible food, and protections against abuse – and ensure independent investigations of deaths.

## MY WORK

### ICE Enforcement

*President Trump and DHS Secretary Noem are using masked ICE agents in unmarked vans to occupy American cities, kill U.S. citizens and brutalize peaceful protestors.*

- I support **impeaching DHS Secretary Kristi Noem** because of the death and chaos that her leadership has brought to communities across America.
- I support legislation to **prohibit ICE agents from wearing masks** during arrests and require DHS officers to use body and vehicle cameras during every immigration enforcement operation.
- I support legislation that only allows ICE to use **force only when no reasonable alternative exists** and requires federal immigration officers to be trained in de-escalation.

### DHS Detention

*DHS is detaining immigrants and U.S. citizens at overcrowded facilities and failing to provide medical services, food, and legal counsel to individuals.*

- I **conducted first-hand congressional oversight** at the privately-run ICE facility in Tacoma.
- I support legislation to **end child and family detention** and prohibit DHS from using private, for-profit facilities for immigration detention.
- I support legislation that will require DHS to provide detained individuals with **in-person medical exams, safe drinking water, adequate meals**, private and sanitary restrooms and basic personal hygiene products.

### Due Process for Immigrants

*ICE agents have disregarded constitutional protections for noncitizens and U.S. citizens alike.*

- I **have helped individuals** detained by ICE and CBP in Northwest Washington **access legal counsel**.
- I demand **full, independent investigations** into the killings of Renee Good, Alex Pretti and other DHS-related shootings, and full accountability for those responsible.
- I support legislation to require DHS to provide individuals in immigration detention with **unlimited communication with legal counsel**.
